[*Benefits for Mind, Body and Work Ability Seen in Medicaid Expansion*](#) is an article on the University of Michigan Health site by Kara Gavin about study findings that suggest that expanding Medicaid to more low-income adults helped many of them feel healthier and do a better job at work or a job search, just one year after they got their new health coverage.

[*Measuring and improving the quality of mental health care: A global perspective*](#) is an article in *World Psychiatry* by Amy M. Kilbourne and colleagues who present a framework for promoting quality measurement as a

tool for improving quality of mental health care.

[*Mental Illness Will Cost the World \\$16 USD Trillion by 2030*](#) is an article from the Carter Center published last year in *Psychiatric Times* about a Lancet Commission report on mental health that said mental disorders are on the rise in every country in the world and will cost the global economy \$16 trillion by 2030...due primarily to early onset of mental illness and lost productivity.

[*Long-term effects of rent supplements and mental health support services on housing and health outcomes of homeless adults with mental illness: extension study of the At Home/Chez Soi randomized controlled trial*](#) is an article in *The Lancet* by Dr. Vicky Stergiopoulos and colleagues that discusses how rent supplements and mental health support services had an enduring positive effect on housing stability for homeless adults with mental illness in a large, resource-rich urban centre, with a larger impact on individuals with high support needs than moderate support needs.

[*Eliminating Wasteful Health Care Spending – Is the United States Simply Spinning Its Wheels?*](#) is an opinion piece on *JAMA Network* by Dr. Jose F. Figueroa and colleagues who suggest that the United States has spent too little time tackling the bigger drivers of wasteful spending...pricing failures an administrative complexity. Policy maker action involves considerable policy intervention from federal and state governments, Also strategies should focus on streamlining processes between clinicians and payers, standardizing quality measures and reporting for value-based contracts, and reducing the complexity of prior authorizations.

[*Op-Ed: Humana study reveals \\$265 billion wasted on health care each year in the United States*](#) is an opinion piece by Bruce D. Broussard, president and CEO of Humana for CNBC who reports on a ground-breaking study by Humana that revealed that \$1 of every \$4 spent annually is being wasted; says a new value-based model needs to be adopted in the industry; and that the model must be an integrated approach that includes behavioral, pharmacy, social determinants of health, home health and primary care.
