**Our Recent Work: Conversations with Policymakers** 



The first week of December, the Farley Center hosted the inaugural class of the <u>National Academy of Medicine</u> <u>State Health Policy Fellowship</u>. The fellows met with policymakers, health care leaders, and advocates to discuss mental health, health care access, and health policy innovation. During their jam-packed schedule, they <u>met with leaders</u> across many Colorado state agencies, health policy non-profits, and the Attorney General's office.

Last Wednesday, the Farley Center completed its third annual educational workshop for Colorado legislators on the health care system in Colorado, *Designing Health Policy*. A bipartisan group of representatives, senators, and their aides heard from Farley Center scholar Kyle Leggott, MD, and State Policy Director Lauren S. Hughes, MD, MPH, MSc, MHCDS, FAAFP, on Colorado's health care system and how it is regulated.

## Help Us Learn More about Firearm Injury Prevention Strategies in Primary Care

Farley Center scholar Bahroze Rakeen is recruiting participants for his study, "Clinicians' perspectives on interventions for reducing firearm injury in at-risk patients and barriers to implementation" (COMIRB# 24-1583). This research study is designed to learn more about licensed Colorado primary care providers' experience with managing risks of firearm related injuries, awareness of extreme risk protection orders (ERPO), and to identify the range of options providers rely on before considering an ERPO.

If you choose to participate, you will complete an interview as a key informant followed by a brief Qualtrics survey. The interview will last 30-45 minutes. At the end of the interview, participants will be emailed a \$75 digital gift card to thank them for their time and participation.
