




#### Designing Health Policy

On Wednesday, December 10th, the Farley Health Policy Center convened Colorado legislators for their annual Designing Health Policy event, a half-day, nonpartisan forum designed to foster collaborative learning and equip policymakers with actionable insights on health and health care in Colorado. This year's session was shaped by conversations with legislators in advance, ensuring the agenda reflected their priorities and questions.

Colorado's health care system faces pressing challenges, from rising costs and coverage gaps to rural access and behavioral health needs. Through nonpartisan education, trusted data resources, and practical tools, Farley aims to strengthen legislators' capacity to design evidence-based health policy that is responsive to the needs of Coloradans.

#### Legislative Updates Resume in January

The Farley Center will continue to offer monthly legislative updates during the 2026 session from 12:00-1:00 p.m. on the fourth Monday of each month, January through April, and the third Monday in May. These sessions are educational updates about relevant health legislation debated in the 2026 Colorado General Assembly for University and partner institution professionals and students.
