Message from the Farley Center

Dear Alison,

Last month we hosted our fifth and final Colorado legislative update session. This year, in addition to discussing state bills, we provided analysis and insights into the federal budget process with specific focus on the impacts on Medicaid funding and services in Colorado. Overall, we covered 29 bills out of the 733 measures introduced.

 State budget woes with the Joint Budget Committee working hard to resolve a \$1.2 billion shortfall. Despite their ability to craft a state budget without severe cuts to

Major themes this legislative session included:

- Medicaid or education, the underlying problems causing budget shortfalls will continue without reform to the Colorado Taxpayer's Bill of Rights (TABOR).
 Conflicts between Democratic legislators and Democratic Governor Polis intensified, with disagreement over unionization requirements and regulation of technology companies in the state.

 A continued focus on firearm injury prevention, with 16 firearm-related bills debated and 13 passed.
 Timely response to the Trump administration's executive orders and other federal
