Message from the Farley Center



People across the country are struggling to access primary care. Practices face challenges in recruiting and retaining providers.

These workforce shortages are driven by large and pervasive issues plaguing primary care, including historic underfunding relative to other specialties and a reliance on fee-for-service payment. Payment reform is critical to improving primary care and the health care system. Farley Center research and products have covered key issues in payment reform over the past

decade. A few weeks ago, we published the results of our latest project, which focused on state policies to advance primary care payment reform in the commercial sector. With recent federal cuts to primary care APM demonstration projects, state work is more important than ever. Our research examines five states that are advancing primary care APM policy for the commercial sector, with the goal of better supporting the foundation of the health care

system. Insights from these states provide useful takeaways and points of caution for others beginning this work. We encourage you to share widely with primary care policymakers and champions. Stephanie
