Colorado's housing market is so strained it's endangering domestic violence victims, advocates say is a story in *The Denver Post* by Elizabeth Hernandez about how advocates warn it's not sustainable to connect the state's most disenfranchised with housing in a hostile market.

Rediscovering the Importance of Free and Charitable Clinics is an opinion piece in *The New England Journal of Medicine* by Mark A. Hall, JD about how these clinics help overcome financial and logistical barriers to care, but stable and predictable funding as well as a better understanding of such clinics and their work, is required.



Colorado governor seeks reversal of federal judge's decision to block new law banning gun sales to anyone under 21 is a post in *The Colorado Sun* by Jesse Paul about how Gov. Polis is seeking an expedited reversal of last week's ruling to block enforcement of a new state law barring anyone younger than 21 from purchasing a firearm.

The Water Surrounding the Iceberg: Cultural Racism and Health Inequities is a post on *The Milbank Quarterly* by Eli K. Michaels and colleagues about how cultural racism permeates all levels of society, uplifts other dimensions of racism, and contributes to health inequities. This paper advances cultural racism as the "water surrounding the iceberg," allowing it to float while obscuring its base.

Some Colorado hospitals are still struggling financially, while the

picture is improving for others is a post on *The Colorado Sun* by John Ingold about how the Colorado Health Association says nearly half of the state's hospitals are losing money on patient care indicating that "revenue from patient care is not covering what it costs to provide that care."

Costenheimer is a post on the *Milbank Memorial Fund* blog by Chris Koller about a five-hour recording of Connecticut's first health care cost growth benchmark hearing during which they analyze the drivers of Connecticut's health care cost growth and setting expectations for a future annual rate of growth of 2.9% or less. Chris states that "all participants in the health care system must accept responsibility and contribute to a viable solution, instead of failing to show up, blaming the data, or passing the buck."

<u>Preparing Physicians for the Clinical Algorithm Era</u> is an opinion piece in *The New England Journal of Medicine* by Katherine E. Goodman and colleagues about the use of clinical decision support systems and the need to ensure they are safe and effective for clinical use.

Opioid settlements from Big Pharma are helping Colorado communities fight fentanyl is a post in *The Colorado Sun* by Jennifer Brown about how the state plans to use more than \$700 million from opioid settlements to build treatment centers and prevention programs.

Promoting Health Equity by Changing How We Pay for Care is a post on *The Commonwealth Fund* blog by Celli Horstman that suggests reforming how we pay for care is one of the many tools the health system has to improve equity. These inequities are both preventable and treatable, and the status quo won't make it happen.

Insurance brokers are giving the Colorado Option a fair shot is an opinion piece by Leah Denzel and Meagan Fearing for *The Colorado Sun* that suggests that if folks are not choosing the public health insurance option, it's because other plans cost less and suit preferences better. This piece is in response to a previous guest column that suggested the inability for the Colorado Option to deliver lower premiums and high enrollment is, in part, the fault of Colorado's health insurance brokers.



AHA News: What Is Shared Decision-Making, and How Can It Help Patients? is an article in *U.S. News* about a new report from the AHA that explains the importance of shared decision-making and identifies barriers to its use and highlights gaps in the research about it. The

concept has its roots in cancer in the 1980s and has gradually spread to other fields. Done right, the conversation leads to a tailored approach to treatment that balances the best evidence-based care with the patient's goals.

Supporting Black Maternal Health Clinicians as an Avenue to Improving Maternal Outcomes is a post on the Milbank Memorial Fund blog by Faith Mitchell and Kima Joy Taylor about increasing the participation of Black clinicians in the maternal and perinatal health field is an essential step toward improving Black birth outcomes. The authors also suggest three policy principles to increase the numbers of Black birthing clinicians and supporting their success that relate to recruitment, support, and retention.



Medical-Legal Partnerships is an article by John Kezer and Jessica Pekala in *Colorado Law* that explains the use of MLPs to improve the treatment of health care patients.
