[Congress wants more red-flag laws. But GOP states, gun groups resist](#) is a story in *The Washington Post* by Kimberly Kindy about how research by the Injury and Violence Prevention Center at the Colorado School of Public Health found 85% of protection orders granted by judges were filed by law enforcement.

[How a Colorado Springs school co-op saves hundreds of thousands of dollars in health insurance costs](#) is a story in *The Colorado Sun* by Erica Breunlin about how partnering with a Littleton-based firm provides a partially self-funded insurance plan, a cooperative that has “cut out the fraud, waste, and abuse within the health insurance world.”

Jost about how explicitly including race or ethnicity as a factor in government allocation of resources raises legal concerns.
