As Al Paves the Way for Healthcare Innovation, Can We Avoid the Potholes? is a story on the CU Anschutz Medical Campus website by Jayashree Kalpathy-Cramer, chief of the new Division of Artificial Medical Intelligence in the CU Department of Ophthalmology, and director of CCTSI's Health Informatics on the CU Anschutz Medical Campus. The author discusses how Al models are used in research and beyond, building an Al model for retinopathy of prematurity, and bringing together a community to address Al concerns.

A Multitiered Mentorship Model – Fostering Inclusive Pathways to Health Careers is a perspective piece in *The New England Journal of Medicine* by Dr. José A. Caro and colleagues about a program, STEM+M Connect that aims to foster a diverse health care workforce using a multitiered near-peer mentoring program for navigating key academic transition points by building career awareness, a sense of belonging, and social networks.
