<u>Facing the New COVID-19 Reality</u> is a perspective piece in the *New England Journal of Medicine* by Dr. Wafaa M. El Sadr and colleagues about navigating the current moment in the COVID-19 pandemic and learning lessons from past successes and missteps.

Experts urge better opioid rescue drug access to save lives is an AP story by Geoff Mulvihill and Sharon Johnson that reports that funding and distribution programs remain spotty due to inadequate support from government and private groups such as chambers of commerce.



Making Health Care More Affordable: A Playbook for Implementing a State Cost Growth Target is a tool posted on the *Milbank Memorial Fund* site that aims to provide a program design and implementation roadmap for states that are interested in, or in the process of, establishing a target. It offers concrete steps, practical tools, best practice strategies, and insights to guide states through the work.

Fifty Years of Trust Research in Health Care: What Does It Mean for Policymakers is a post on the Milbank Memorial Fundblog by Jodyn Platt and Lauren A. Taylor that reviews 50 years of research on trust in health care services to inform the health policy and health services research communities about themes, key findings, and methodological gaps.

AG Weiser 'happy to work' on expansion of Colorado's red flag law is a story on *Colorado Newsline* by Sara Wilson about how Colorado Attorney General Phil Weiser announced that he will work with lawmakers to draft legislation to expand the state's Extreme Risk Protection Order law.



Primary Care Collaborative Launches State Primary Care Investment Hubis an article on the *Milbank Memorial Fund* site by Mary Louise Gilburg about a partnership between the Milbank Memorial Fund and the Primary Care Collaborative. It is designed to provide information and analysis about primary care investment at the state level to advocates, researchers, and state officials interested in reorienting state health systems and primary care.

Massachusetts Primary Care Dashboard is a dashboard of metrics to monitor the health of the primary care system in the Commonwealth. The dashboard measures the health of primary care along four domains: 1) finance, 2) capacity, 3) performance, and 4) equity.

A new study on marijuana legalization in Colorado answers the question: Has legal pot made other drug problems worse is a story in *The Colorado Sun* by John Ingold about a study by researchers at the University of Colorado and the University of Minnesota that uses long-term data on twins to assess the impacts of cannabis legalization.

Popular...to a Point: The Enduring Political Challenges of the Public Option is a post in *The Milbank Quarterly* by Adrianna McIntyre and colleagues that reports on the 2020 national survey that found bipartisan support for a specific public option policy, but also divergent attitudes toward government that may thwart insurance reform efforts.
