<u>Searching for the Family Doctor: Primary Care on the Brink</u> is a recently published book by Dr. Timothy Hoff who writes how the specialty of family medicine has always existed within the context of an unsupportive American health care system that underemphasizes and undervalues primary care.

<u>COVID-19: A Virtual Conversation Series</u> is a recurring series tracking the impacts of the pandemic in Colorado and beyond presented in partnership by The Institute for Science & Policy and the Colorado School of Public Health. Key lessons include communication matters, leadership matters, and how science can achieve remarkable things.

<u>Match Day Ceremony Reveals Residency Locations for Graduating Students</u> <u>at CU School of Medicine</u> is the story about last Friday's match day for CU School of Medicine graduates. This was an especially exuberant event given that COVID interfered with the past couple of celebrations.

First-generation medical students and The Match is a post on the AAMC site in which the organization estimates that 12.4% of those attending MD-granting medical schools are first-generation college students of the 2021-22 class.

For Trailblazing Doctor, History and Empowerment Go Hand in Hand is a post on the *CU Anschutz* site by Chris Casey about a gift from Dr. Helen Morris to the CU Center for Bioethics and Humanities to fund its new American Jewish Experience in Medicine Program.

<u>12 Teenagers on What Adults Don't Get about their Lives</u> is an opinion piece in *The New York Times* by Patrick Healy and Lulu Garcia-Navarro who write about what they learned in a focus group with teens when trying to hear and understand the views of wider cross-sections of Americans whose voices are often not heard.

Late to Bed, Early to Rise... is this week's newsletter from Ben Miller about how a culture of sleeplessness is harming our mental health.

The Science of Helping Out is a post in *The New York Times* by Tara Parker-Pope that discusses how those who help others during a crisis, are the people who cope best.

POLICY EFFORTS

Youth violence remains a major public health crisis in Aurora. City leaders want to address it with new funding. is a story in *The Colorado Sun* by Tatiana Flowers about how marijuana tax revenue will help city leaders provide \$500,000 to several organizations to help prevent youth violence and intervene after a violent incident has occurred.

The Logic of Policies to Address Income-Related Health Inequity: A Problem-Oriented Approach is a post on *The Milbank Quarterly* by Seth A. Berkowitz that suggests how addressing income-related health inequities requires a set of overlapping and complementary policy approaches rather than focusing on a single policy.

Electronic Health Records as Biased Tools or Tools Against Bias: A Conceptual Model is an article posted on *The Milbank Quarterly* site by Michael D. Rozier and colleagues that offers a conceptual model showing how the design and subsequent use of EHRs can be subject to bias and can either encode and perpetuate systemic racism or can be used to challenge it. The Affordable Care ACT: Twelve Years Later is a post on *Health Affairs* by Kevin Kimberlin that discusses the advantages of empowering the patient with shared decision-making and how that could result in a clear path to delivering affordable health care to all Americans.

<u>A landmark legal ruling in the fight for mental health equity has been</u> <u>overturned</u> is a post on *The Kennedy Forum* site by Patrick J. Kennedy about a devastating ruling this week that sets America back while struggling to cope with increasing mental health challenges, especially among youth.



Participation, Pricing, and Enrollment in a Health Insurance "Public Option": Evidence from Washington State's Cascade Care Program is an article posted on the *Milbank Memorial Fund* site by Aditi P. Sen and colleagues that examines insurer participation, pricing, and enrollment in the Washington public option. The public option was the lowest premium standard silver plan in 9 of the 19 counties in which it was offered.

Identifying Value-Added Population Health Capabilities to Strengthen Public Health Infrastructure is an article posted on the *Milbank Memorial Fund* site by Rachel Hogg-Graham and colleagues about study findings that suggest how prioritizing the delivery of value-added population health capabilities may help communities increase their public health system's capacity and improve health outcomes.

How Does Use of Mental Health Care Vary by Demographics and Health Insurance Coverage? is an issue brief posted on the *Kaiser Family Foundation* site about how the use of mental health care varies by demographics and health insurance coverage.

<u>Closing the Health Justice Gap: Access to Justice in Furtherance of Health</u> <u>Equity</u> is an article on the *Columbia Human Rights Law Review* by Yael Cannon, director of the Health Justice Alliance Law Clinic at Georgetown University Law Center, which discusses how the health justice and access to justice movements can be aligned to work in furtherance of health equity.

Literature review: Making the case for medical-legal partnerships, 2013-2020 is an issue brief posted on the *National Center for Medical Legal Partnership* site by Caitlin Murphy that provides an update to a review done in 2013 that demonstrates how MLPs' impact is improving.

Focusing on Structural Racism to Address Social Determinants of Health is a paper from the Corporation for Supportive Housing that provides examples of

how structural racism in housing has affected inequities in social determinants of health and health outcomes.

Racial and Health Equity: Concrete STEPS for Health Systems is a post on the AMA site that contains a toolkit developed in collaboration with *Health Begins* designed to help identify ways to prepare health systems or group practices for conversations about health equity, racial equity, racism, and anti-racism.
