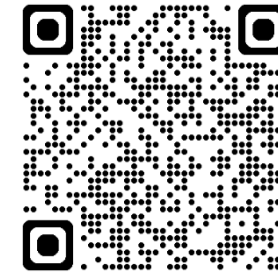

Year 2 Invoicing

- All invoices for work delivered July 2024 – June 2025 (Year 2) must be sent no later than June 6, 2025
 - Remember to include May and June field notes, evaluation task, updated building block assessment, and Q2 2025 Quarterly snapshot
 - Any earlier completed deliverables from this time period that haven't been invoiced for: we are sending a list to each PTO (if applicable) this week
- **Invoices received late may be subject to nonpayment due to fiscal year end deadlines**
- As a reminder, invoices should be sent to dfminvoice@ucdenver.edu and include the following items:
 - Current purchase order number for 1302 (unique to each organization and each scope of work)
 - which deliverables for which practices are included in invoice amount
 - date range work competed
 - unique invoice number (not previously used in another invoice sent to University)

1302 Practices Closing Out Contracts

- 1302 practices have until December 2026 to spend down their funds – wide variety of spend rates
- Per HCPF: Once a practice has submitted and been paid their final invoice (expended and paid all grant funds), we cannot provide them with facilitation or other support.
- HCPF will update PIP as practices send final invoices/request closeout and we will communicate this to the PF and PTO lead.
- Practices will be expected to finish a final building block assessment and close out facilitation before the final invoice will be paid. HCPF to communicate this expectation.

1302 Practices Closing Out Contracts (cont.)

- Practices with contracts ending July 1- September 30
 - Final BBA will be the one due June 15
 - PTO will complete July August Field Note and Closeout Survey within final field note*
- Practices with contracts ending October 1 - December 1
 - Complete all Year 3 deliverables

*Closeout questions are accessed by indicating “Yes” on field note question asking if this is the final field note you will enter for this practice. This will not appear as a separate survey in SPLIT.

- Intent is for your effort for two months of facilitation to be spread across the time period, with at least one meeting in each field note time frame
 - Reach out for guidance for specific practices or situations as needed
- This will be the final scope of work for 1302 facilitation
