Background

- Department of Human Services, Office of Behavioral Health (OBH) assigned responsibility for project direction, oversight, and evaluation
- OBH providing additional support for supplementary patient services through block grant funding

What is Circle of Parents?

Its a Peer Support Program designed for parents and caregivers.

Mission

Prevent child maltreatment and strengthen families through mutual self-help parent support groups.

- It provides a friendly, supportive environment led by parents and other caregivers.
- It's a space where anyone in a parenting role can openly discuss the successes and challenges of raising children.
- It's a space where they can find and share support.

The Circle of Parents peer support group addresses all five Strengthening Families' Protective Factors by promoting healthy social connections for parents, and improving parental resiliency.

The Model


- Strengths-Based

Overview - Logistical Aspects

- MOU, budget & contract with Illuminate
- Training and Technical Assistance (Illuminate)
 - All facilitators should be trained through the Illuminate Circle of Parents training program (day training)
