But for rare diseases, one can understand why it’s so costly for a pharmaceutical company to make a drug that they are not going to be able to market to very many patients.”

### [Your Healthy Family: Innovative biosticker will monitor patients' vital signs from their home](#)

**Richard Zane**, UCHealth chief innovation officer and chair of emergency medicine at the CU School of Medicine, said: "The use of the BioSticker device for continuous health monitoring enables us to monitor a patient in their home and recognize when a patient may have an exacerbation of illness even before they notice symptoms. This may reduce hospitalizations, reduce emergency department visits, and shorten hospital stays, significantly reducing health care costs for these patients."
