
Fiscal Year 2023 began July 1, 2022 and ended June 30, 2023

FY 2023 REACH


2,223 participants came from **59** of Colorado's 64 counties

EDUCATIONAL IMPACT

For select series, respondents were asked to rate their ability to complete the learning objectives and act as a local resource on the topic of the ECHO series using a Likert scale of 1 to 5, where 1 is "no ability" and 5 is "expert competency."

The overall change in pre and post ratings from **2.6** to **3.6** demonstrates a *statistically significant* (*p*<.001) *increase in reported self-efficacy.*
