Thank you to our practice partners that have spent time over the past 5 months responding to surveys intended to gather information about how equipped practices are to addressing and respond to COVID-19.

#### Home vs Office for Medication Enhanced Recovery (HOMER)

HOMER is a new national study comparing office-based (observed) and home induction (unobserved) methods for medication assisted treatment (MAT) in patients with opioid use disorder (OUD). Synchronous telehealth is third possible method under consideration for this study.

The HOMER study is a partnership between the State Network of Colorado Ambulatory Practicles and Partners (SNOCAP) and the American Academy of Family Physicians National Research Network.

We are conducting this study to better understand if one induction method works better and to determine if certain patient and practice characteristics make patients better candidates for one method over the other. Results will help fill a gap in the evidence around effectively retaing 0.0D with MAT in primary care settings.

No-cost training for prescribers to complete "X waiver" training to prescribe MAT is available through Practice Innovation Program Colorado. There are limited number of stipends available on a first come. first served basis through September 30, 2020. We do not anticipate a renewal of these funds so this may be the last chance to receive a stipend for this important training!

- \$500 for MDs and DOs (8) hours of training required)
- \$1000 for NPs, PAs, CNMs, CNAs (24 hours of training required)
