- 3. Dissemination: What data will you analyze, write-up, and submit within the first year of the fellowship? (This is often data which has already been collected either by you or your proposed mentor(s) which you could analyze.)
- 4. Skills: What skills will you focus on mastering in the first year of the fellowship and how will you master them? (This often means joining ongoing projects where you gain on-thejob skills training.)
- 5. What will be your plan to develop an independent project? (Please include as much information as possible about the project, how you will attempt to find funding for the project, and a timeline geared towards completing and disseminating project results within the two-year fellowship. This should be developed by discussion with your proposed mentor)
- 3-page project description (minimum 11 Arial font and 0.5" margins on all four sides, single spaced) excluding references
 - o Specific aim / hypothesis
 - o Background
 - Brief description of planned study design
 - Brief timeline for research activity and expected end products of your research (spanning 2 years of funding)
 - o References (in addition to 3-page project description)
