When entering time, employees should *not* select the earning code "HOL" for December 28 and 29. Instead, most employees will record these two dates as **Administrative Leave**.

Essential personnel and those employees with clinical responsibilities and other critical functions requiring them to be on campus during that week will receive equivalent administrative and holiday leave to take at a more convenient time, in coordination with their supervisor, prior to the end of the fiscal year on June 30, 2023.

Juneteenth Personal Observance Day (CU Anschutz Medical Campus and CU Denver)

For the fiscal year ending June 30, 2022, eligible faculty and staff will have an additional holiday to use as a *paid personal day of observance*, which may be used in observance of Juneteenth or on another day of the employee's choosing. Eligible employees may use this day with their supervisor's approval any time <u>before</u> December 31, 2022. In the fiscal year ending June 30, 2023, employees may use their personal observance day <u>before</u> June 30, 2023.

Definitions:

- CU Anschutz Medical Campus: Holidays observed by units specifically serving the CU
 Anschutz Medical Campus and its schools and colleges. holidays observed by units
 specifically serving CU Anschutz Medical Campus and its schools and colleges. If
 employees have critical clinical, research, teaching, or other responsibilities that require
 they work a given holiday, they will be given an alternative day off.
- Consolidated Units: Consolidated units serving both CU Denver and CU Anschutz
 Medical Campus remain open on campus-specific holidays; each employee will request
 either the CU Denver Campus or CU Anschutz Medical Campus holiday schedule for the
 fiscal year. Typically, if the employee has a primary campus, they select that campus
 holiday schedule. Employees should indicate their holiday schedule via the portal under
 My Info and Pay/My Leave/Preferences/Holiday Schedule.
