### Definitions:

*Interprofessional Professionalism*: "Consistent demonstration of core values evidenced by professionals working together, aspiring to and wisely applying principles of altruism and caring, excellence, ethics, respect, communication, and accountability to achieve optimal health and wellness in individuals and communities." (Stern 2006)

*Communication*: Impart of interchange of thoughts, opinions, or information by speech, writing, or signs; "the means through which professional behavior is enacted."

*Respect*: "Demonstrated regard for another person with esteem, deference and dignity. . . personal commitment to honor other people's choices and rights regarding themselves. . . includes a sensitivity and responsiveness to a person's culture, gender, age and disabilities. . . the essence of humanism . . . signals the recognition of the worth of the individual human being and his or her belief and value system."(Stern 2006)

*Altruism and Caring*: Overt behavior that reflects concern, empathy, and consideration for the needs, values, welfare, and well-being of others and assumes the responsibility of placing the needs of the patient or client ahead of the professional interests.

*Excellence*: Adherence to, exceeds, or adapts best practices to prove the highest quality of care.

*Ethics*: Consideration of a social, religious, or civil code of behavior in the moral fitness of a decision of course of action, especially those of a particular group, profession, or individual, as these apply to every day delivery of care.

**Accountability:** Accept the responsibility for the diverse roles, obligations, and actions, including self-regulations and other behaviors that positively influence patient and client outcomes, the profession, and the health needs of society.
