

Nutrition Training in Developmental Disabilities 2022-23

JFK Partners, Colorado's University Center of Excellence in Developmental Disabilities Education, Research and Service (UCEDD) and Leadership Education in Neurodevelopmental Disabilities (LEND) Program is interviewing for a Nutrition Traineeship **to begin August 1, 2022.**

The purpose of the LEND program is to improve the health and well-being of individuals with autism spectrum disorder and other developmental disabilities by preparing an interdisciplinary cadre of professionals to take leadership roles in providing services, improving systems of care, and building inclusive communities for these individuals and their families.

Eligibility:

- Applicants must have received the required graduate degree (Master's) and be a Registered Dietitian or RD eligible.
- Must be available to take coursework on Tuesdays (Sept-May) and attend a Leadership Course (daily Aug 1-5 and 8-12, 2022 from 2:00-5:00 pm).
- The trainee receiving a stipend must be a citizen or a non-citizen national of the United States or have been lawfully admitted for permanent residence, as evidenced by a currently valid Permanent Resident Card [USCIS Form I-551] or other legal verification of such status, by the start of the training grant. A noncitizen national is a person who, although not a citizen of the United States, owes permanent allegiance to the United States.

Participation during COVID-19: It is preferred that all courses and clinical/community observations be completed in-person to gain the most from the interdisciplinary cohort, however during COVID-19, it may be required to complete them online. For this reason, applicants need to have access to a computer and a reliable internet connection. Please notify us in your application if this is a barrier to your participation.

JFK Partners is committed to the recruitment and retention of diverse faculty, staff, and trainees to enrich the training environment and better prepare professionals and advocates to promote health equity, wellness, social equality, and reduced disparities. While we have had challenges recruiting trainees that match Colorado's racial, ethnic, and cultural diversity, it is a priority for JFK Partners to increase workforce representation to reflect the community we serve. Bilingual Spanish-speaking applicants, in addition to those with historically underrepresented racial, ethnic, and cultural identities are encouraged to apply.

Program Description: Nutrition Trainees will engage in a 12-hour/week program of academic and practicum experiences to advance their skills in the areas of leadership, cultural competency, family centered care, advocacy, public policy, clinical knowledge, research, and other topics associated with improving healthcare and inclusion for individuals with autism or other developmental disabilities.

Trainee experiences include:

- Weekly mentorship
- Coursework in Leadership (daily Aug 1-5 and 8-12, 2022 from 2:00-5:00 pm)
- Coursework in Key Concepts in Neurodevelopmental Disabilities (Tues mornings Sept-Apr)

- Coursework in Policy/Advocacy (Five Tues didactic sessions 10:30-12:30 Jan-Mar and IDD Awareness Day at Colorado Capitol)
- Attendance at the Annual JFK Partners Autism Conference (Oct)
- Training experience resulting in a scholarly project with a presentation and product that is completed and presented by the trainee by the end of the training experience.
- Optional coursework in Screening & Assessment, and Intervention (Tues afternoons Sept-Apr).

Support: A stipend of \$646/mo for 10 months for this part-time (12-hours/week), pre-doctoral trainee position is available for those completing the program in 300 hours or more.

Courses completed during the training are eligible to be considered as electives for the <u>MPH in Maternal and</u> <u>Child Health</u>. Tuition for course credit is not provided above the stipend amount. Trainees who wish to receive credit need to apply to be a Non-Degree Seeking Graduate Student with the University of Colorado Anschutz Medical Campus, register, and pay for the courses.

This position and funding are contingent upon JFK Partners receiving grant funding. This position is funded by a grant from the Maternal and Child Health Bureau, Award #2 T73MC11044-14-00, July 1, 2021-June 30, 2026.

Application: Our application requires the submission of the following documents:

- 1. Cover Letter Statement of Interest Please include the answers to the following:
 - Describe why training at JFK Partners interests you.
 - Have you had any experience with Leadership Education in Neurodevelopmental Disabilities (LEND) training? If so, which program?
 - Describe past experiences related to working with individuals with autism or other developmental disabilities (ASD/DD) and your interest in working with this population.
 - Are you a family member of an individual with ASD/DD? (Disclose to your comfort.)
 - Describe any coursework and/or professional or volunteer experiences with policy or advocacy.
 - How does advanced training in neurodevelopmental disabilities fit with your future professional plans?
- 2. Graduate school transcripts (unofficial)
- 3. Resume or Curriculum Vita (CV)
- 4. Three (3) letters of recommendation from faculty or supervisors familiar with your interests and work relevant to this training position.
